Lethans Wind Farm Construction Liaison Panel update and notification of planned road upgrades on Mansfield Road.

Both Lethans and Lethans East Wind Farms have consent to use Mansfield Road as the primary access point. However, having listened to the local community, we are looking at alternative routes to site.

While we explore these alternative access options, we must still fulfill the obligations in our existing planning consents. That means we must complete permanent upgrade works on Mansfield Road this spring.

These works are scheduled to be completed between 9 March and 1 May 2026. If an alternative route does not prove viable then these works are essential to ensure safe and efficient access for construction traffic which would be at least 12 months away.

All work will be undertaken by our experienced contractor, AE Yates, and include:

- The creation of 19 new passing places
- Earthworks and adjustments to walls or fencing as required
- Installation of additional signage


Work will be taking place between the hours of 0800 and 1800 Monday to Friday. During these hours there will be Stop/Go traffic management in place, outside these hours there will be no restrictions, and access will be resumed as normal.

Alternative access review update

At the last meeting on 25 November 2025 we presented several potential access routes suggested by the local community during our earlier sessions. Since then, our project team has continued to carefully assess these options in more detail to determine if they could form a viable alternative access for the construction traffic.

Work completed on alternative access points to date includes:

- Swept path analysis
- Gradient assessment
- Topographical review
- Financial appraisal of constructing a new access road
- Winter bird surveys

To ensure we gather all the information required, we have engaged with specialist consultants and statutory bodies such as NatureScot. This work is ongoing and includes completing breeding bird surveys as well as wider environmental studies. This will help us determine whether any alternative access route could progress to the next stage and help us determine if viable planning and business cases can be made. This is a process that may take several more months.
